# Narrandera Shire Council: Plan B – Win a Swag Competition | 'CONDITIONS OF ENTRY'

- PRIZE CLAIM DATE
- Information on how to enter and prizes and any details form part of these 'Conditions of Entry'. Entry into the promotion constitutes deemed acceptance of these Conditions of Entry. Entries must comply with these Conditions of Entry to be valid. This promotion is governed by the laws of NSW.
