Introduction	Council has established the Internal Audit Officer as a key component of the Council's governance and assurance framework, in compliance with the Departmental Chief Executive's Guidelines for Risk Management and Internal Audit for Local Government in NSW. This Charter provides the framework for the conduct of the Audit, Risk and Improvement Committee in the Council and has been approved by the Governing Body taking into account the advice of the Council's Audit, Risk and Improvement Committee.
1. Purpose of internal audit	<p>Internal audit is an independent, objective assurance and consulting activity designed to add value and improve the Council's operations. It helps the Council accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, control and governance processes (as defined by the International Standards for the Professional Practice of Internal Auditing 2017).</p> <p>Internal audit provides an independent and objective review and advisory service to provide advice to the Governing Body, General Manager and Audit, Risk and Improvement Committee about the Council's governance processes, risk management and control frameworks and its external accountability obligations. It also assists the Council to improve its business performance.</p>
2. Independence	<p>Council's Internal Audit Officer is to be independent of the Council so it can provide an unbiased assessment of the Council's operations and risk and control activities.</p> <p>Internal Audit Officer reports functionally to the Council's Audit, Risk and Improvement Committee on the results of completed audits, and for strategic direction and accountability purposes, and reports administratively to the General Manager to facilitate day-to-day operations. Internal audit activities are not subject to direction by the Council and the Council's management has no role in the exercise of the Council's internal audit activities.</p> <p>The Audit, Risk and Improvement Committee is responsible for communicating any internal audit issues or information to the Governing Body. Should the Governing Body require additional information, a request for the information may be made to the chair by resolution. The chair is only required to provide the information requested by the Governing Body where the chair is satisfied that it is reasonably necessary for the Governing Body to receive the information for the purposes of performing its functions under the Local Government Act. Individual Councillors are not entitled to request or receive information from the committee.</p>

(To be added upon completion of position PD at a later date.)</p> <p>The General Manager must consult with the Chair of the Council's Audit, Risk and Improvement Committee before appointing or making decisions affecting the employment of the Internal Audit Officer. If the Internal Audit Officer is dismissed, the General Manager must report the reasons for their dismissal to the Governing Body.</p> <p>Where the Chair of the Council's Audit, Risk and Improvement Committee has any concerns about the treatment of the Internal Audit Officer, or any action taken that may compromise their ability to undertake their functions independently, they can report their concerns to the Governing Body.</p> <p>The Internal Audit Officer is to confirm at least annually to the Audit, Risk and Improvement Committee the independence of internal audit activities from the Council.</p>
3. Authority	<p>Council authorises the Internal Audit Officer to have full, free and unrestricted access to all functions, premises, assets, personnel, records and other documentation and information that the Internal Audit Officer considers necessary for the Internal Audit Officer to undertake their responsibilities.</p> <p>All records, documentation and information accessed while undertaking internal audit activities are to be used solely for the conduct of those activities. The Internal Audit Officer and individual internal audit staff are responsible and accountable for maintaining the confidentiality of the information they receive when undertaking their work.</p> <p>All internal audit documentation is to remain the property of Council, including where internal audit services are performed by an external third-party provider.</p> <p>Information and documents pertaining to the Internal Audit Officer are not to be made publicly available. The Internal Audit Officer may only release Council information to external parties that are assisting the Internal Audit Officer to undertake its responsibilities with the approval of the General Manager, except where it is being provided to an external investigative or oversight agency for the purpose of informing that agency of a matter that may warrant its attention.</p>
4. Role	<p>The Internal Audit Officer is to support the Council's Audit, Risk and Improvement Committee to review and provide independent advice to the Council in accordance with section 428A of the Local Government Act 1993. This includes conducting internal audits of Council and monitoring the implementation of corrective actions.</p> <p>The Internal Audit Officer is to also play an active role in:</p> <ul style="list-style-type: none"> • developing and maintaining a culture of accountability and integrity • facilitating the integration of risk management into day-to-day business activities and processes, and • promoting a culture of high ethical standards. <p>Internal Audit Officer has no direct authority or responsibility for the activities it reviews. The Internal Audit Officer has no responsibility for developing or implementing procedures or systems and does not prepare records or engage in Council functions or activities (except in carrying out its own functions).</p>
5. Internal Audit Officer	5.1 Outsourced internal audit function

	<p>Council's Internal Audit Officer is a member of Council's staff with sufficient skills, knowledge and experience to ensure it fulfils its role and responsibilities to the Council and the Audit, Risk and Improvement Committee. The Internal Audit Officer must be independent, impartial, unbiased and objective when performing their work and free from any conflicts of interest.</p> <p>Responsibilities of the Internal Audit Officer include:</p> <ul style="list-style-type: none"> • contract management • managing the internal audit budget • ensuring the external provider completes internal audits in line with the Audit, Risk and Improvement Committee's annual work plan and four-year strategic work plan • forwarding audit reports by the external provider to the Audit, Risk and Improvement Committee • acting as a liaison between the external provider and the Audit, Risk and Improvement Committee monitoring the Council's implementation of corrective actions that arise from the findings of audits and reporting progress to the Audit, Risk and Improvement Committee, and • monitoring the Council's implementation of corrective actions that arise from findings of audits and reporting progress to the Audit Risk and Improvement Committee. and • assisting the Audit, Risk and Improvement Committee to ensure the Council's internal audit activities comply with the Guidelines for Risk Management and Internal Audit for Local Government in NSW. <p>[Details of any dual responsibilities and independence safeguards]</p> <p>[Details of any shared arrangements]</p>
	<p>5.2 Out-sourced internal audit team</p> <p>Council is to contract an external third-party provider to undertake its internal audit activities. To ensure the independence of the external provider, the Internal Audit Officer is to ensure the external provider:</p> <ul style="list-style-type: none"> • does not conduct any audits on specific Council operations or areas that they have worked on within the last two years • is not the same provider conducting the Council's external audit • is not the auditor of any contractors of the Council that may be subject to the internal audit, and • can meet the Council's obligations under the Guidelines for risk management and internal audit for local government in NSW. <p>The Internal Audit Officer must consult with the Audit, Risk and Improvement Committee and General Manager regarding the appropriateness of the skills, knowledge and experience of any external provider before they are engaged by the Council.</p>
6. Performing internal audit activities	<p>The work of the Internal Audit Officer is to be thoroughly planned and executed. The Council's Audit, Risk and Improvement Committee must develop a strategic work plan every four years to ensure that the matters listed in Schedule 1 are reviewed by the committee and the internal audit function. The strategic work plan must be reviewed at least annually to ensure it remains appropriate.</p> <p>The committee must also develop an annual work plan to guide the work of the internal audit function over the forward year.</p>

	<p>All internal audit activities are to be performed in a manner that is consistent with relevant professional standards including the International Standards for the Professional Practice of Internal Auditing issued by the Institute of Internal Auditors and [current Australian risk management standard]. ISO 31000:2018 International Standard on Risk Management?</p> <p>The Internal Audit Officer is to provide the findings and recommendations of internal audits to the Audit, Risk and Improvement Committee at the end of each audit. Each report is to include a response from the relevant Senior Manager.</p> <p>The Internal Audit Officer is to establish an ongoing monitoring system to follow up Council's progress in implementing corrective actions.</p> <p>The General Manager, in consultation with the Audit, Risk and Improvement Committee, is to develop and maintain policies and procedures to guide the operation of the Council's Internal Audit Officer.</p> <p>The Internal Audit Officer is to ensure that the Audit, Risk and Improvement Committee is advised at each of the Committee's meetings of the internal audit activities completed during that quarter, progress in implementing the annual work plan and progress made implementing corrective actions.</p>
7. Conduct	<p>Internal audit personnel must comply with the Council's Code of Conduct. Complaints about breaches of Council's Code of Conduct by internal audit personnel are to be dealt with in accordance with the Procedures for the Administration of the Model Code of Conduct for Local Councils in NSW. The General Manager must consult with the Council's Audit, Risk and Improvement Committee before any disciplinary action is taken against the Internal Audit Officer in response to a breach of the Council's Code of Conduct.</p> <p>Internal auditors must also comply with the Code of Ethics for the Professional Practice of Internal Auditing issued by the Institute of Internal Auditors.</p>
8. Administrative Arrangements	<p>8.1 Audit Risk and Improvement Committee Meetings</p> <p>The Internal Audit Officer will attend Audit, Risk and Improvement Committee meetings as an independent non-voting observer. The Internal Audit Officer can be excluded from meetings by the committee at any time.</p> <p>The Internal Audit Officer must meet separately with the Audit, Risk and Improvement Committee at least once per year.</p> <p>The Internal Audit Officer can meet with the Chair of the Audit, Risk and Improvement Committee at any time, as necessary, between committee meetings.</p>
	<p>8.2 External Audit</p> <p>Internal and external audit activities will be coordinated to help ensure the adequacy of overall audit coverage and to minimise duplication of effort.</p> <p>Periodic meetings and contact between internal and external audit shall be held to discuss matters of mutual interest and to facilitate coordination.</p> <p>External audit will have full and free access to all internal audit plans, working papers and reports.</p>
	<p>8.3 Dispute Resolution</p> <p>The Internal Audit Officer should maintain an effective working relationship with the Council and the Audit, Risk and Improvement Committee and seek</p>

	<p>to resolve any differences they may have in an amicable and professional way by discussion and negotiation.</p> <p>In the event of a disagreement between the Internal Audit Officer and the Council, the dispute is to be resolved by the General Manager and/or the Audit, Risk and Improvement Committee. Disputes between the Internal Audit Officer and the Audit, Risk and Improvement Committee are to be resolved by the Governing Body.</p> <p>Unresolved disputes regarding compliance with statutory or other requirements are to be referred to the Departmental Chief Executive in writing.</p>
	<p>8.4 Review Arrangements</p> <p>The Council's Audit, Risk and Improvement Committee must review the performance of the internal audit function each year and report its findings to the Governing Body. A strategic review of the performance of the Internal Audit Officer must be conducted each Council term that considers the views of an external party with a strong knowledge of internal audit and reported to the Council.</p> <p>This charter is to be reviewed annually by the committee and once each council term by the Governing Body. Any substantive changes are to be approved by the Governing Body.</p>

	<p>A.2 External audit</p> <ul style="list-style-type: none"> • Act as a forum for communication between the governing body, General Manager, Senior Management, the internal audit function and external audit • Coordinate as far as is practicable, the work programs of internal audit and external audit • Provide input and feedback on the Financial Statements and performance audit coverage proposed by external audit and provide feedback on the audit services provided • Review all external plans and reports in respect of planned or completed audits and monitor council's implementation of audit recommendations • Provide advice to the Governing Body and/or General Manager on action taken on significant issues raised in relevant external audit reports and better practice guides
B. Risk	<p>B.1 Risk management</p> <p>Review and advise the Council:</p>
